Subject:-Application dated 26.10.2021 of The Director General, Directorate of Ayush, Haryana, Ayush Bhawan, Near Youth Hostel, Sector-03, Majri Chowk, Panchkula, Haryana-134109 on seeking permission of the Medical Assessment and Rating Board for Indian system of Medicine, National Commission for Indian System of Medicine to establish new Ayurvedic Medical college in the name of Baba Khetanath Govt. Ayurvedic College and Hospital, village-Patikara, Narnaul, Dist- Mahendragarh, Haryana (Inst. ID-AYU0714) with 100 seats in UG (BAMS) course under section 29 of NCISM Act, 2020 from the academic session 2022-23-reg.

Sir/Madam,

With reference to the subject mentioned above, I am directed to inform you that in pursuance of the provision of National commission for Indian System of Medicine Act, 2020, the Indian Medicine Central Council Act, 1970 (48 of 1970) has been repealed with effect from the 11th day of June, 2021. With effect from the said date, the Central Council of Indian Medicine constituted under sub-division (1) of section 3 of the Indian Medicine Central Council Act, 1970 (48 of 1970) shall stand dissolved. Now, in exercise of the powers conferred by sub-section (3) of the section 1 of the said Act, the Central Government hereby notifies that all the provisions of the National Commission for Indian System of Medicine Act, 2020 has been come into force with effect from the 11th day of June, 2021 and as per regulation 59 (2) of The National Commission for Indian System of Medicine ACT, 2020, Medical standards, requirements and other provisions of the Indian Medicine Central Council Act, 1970 and the rules and regulations made thereunder shall continue to be in force and operate till new standards or requirements are specified under this Act or the rules and regulations made thereunder. Further, the provision of concerned regulations which are inconsistent with the provision of NCISM ACT 2020 shall not be applicable.

1. I am to refer to your application, vide ref no. D.no./2021/34796 dated 26.10.2021 on the subject cited above and to verify the available facilities of teaching and practical training for the intake capacity with 100 seats in UG (BAMS) course from the academic session 2022-23, the college was visited on 27.06.2022 & 28.06.2022 through hybrid mode for LOI by the visitation team of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) and as per direction of competent authority letter of intent was issued to you vide letter even No. dated 26.09.2022 to establish New Ayurveda college in the name of **Baba Khetanath Govt. Ayurvedic College and Hospital, village-Patikara, Narnaul, Dist- Mahendragarh, Haryana (Inst. ID-AYU0714)** for intake capacity with 100 seats in UG (BAMS) course from the academic session 2022-23 under Section 29 of NCISM ACT 2020 and relevant regulations thereunder.
2. The Medical Assessment and Rating Board for Indian System of Medicine (NCISM) had carried out an inspection of the institution again on 01.11.2022 and 02.11.2022 through Hybrid mode to assess the available facilities of teaching and practical training for issuance of Letter of Permission (LOP) to establish new Ayurveda college in the name of **Baba Khetanath Govt. Ayurvedic College and Hospital, village-Patikara, Narnaul, Dist- Mahendragarh, Haryana (Inst. ID-AYU0714)** for intake capacity with 100 seats in UG (BAMS) course from the academic session 2022-23 under section 29 of NCISM Act 2020 and relevant regulations thereunder.
3. In view of above as per the direction of **President, Medical Assessment and Rating Board for Indian System of Medicine (NCISM)**, the assessment report and all other related documents were placed in the 20th Board Meeting of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) dated 25.11.2022. Board discussed the same and recommended to issue letter of Permission for intake capacity with 100 seats in UG (BAMS) course from academic session 2022-23 under section 29 of NCISM Act, 2020.
4. In view of above as per the direction of President, Medical Assessment and Rating Board for Indian System of Medicine (NCISM), the assessment report and all other related documents were placed in the 24th Board Meeting of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) dated 16.12.2022. Board discussed the same and found that college is not fulfilling the basic eligibility criteria to establish new Ayurveda College but on the basis of letter no. BKNAGACH/Acad/2022/1896 dated 01.12.2022 submitted by the Principal, Baba Khetanath Govt. Ayurvedic College and Hospital, Haryana informing about the sanctioned post of teaching faculty in all the 14 departments by the Government of Haryana vide letter no. 1/61/2021-1 HB II dated 26.08.2022, Board discussed and recommend to issue letter of Permission (LoP) to establish new Ayurveda college for intake capacity with 100 seats in UG (BAMS) course under section 29 of NCISM Act, 2020 from academic session 2022-23

5. Therefore, it has been decided by the president, Medical Assessment and Rating Board for Indian System of Medicine (NCISM) **to issue Letter of Permission (LOP) to The Director General, Directorate of Ayush, Haryana, Ayush Bhawan, Near Youth Hostel, Sector-03, Majri Chowk, Panchkula, Haryana-134109 to establish new Ayurvedic Medical college in the name of Baba Khetanath Govt. Ayurvedic College and Hospital, village-Patikara, Narnaul, Dist- Mahendragarh, Haryana (Inst. ID-AYU0714) with 100 seats** in UG (BAMS) course from the academic session 2022-23 under Section 29 of NCISM ACT 2020 and relevant regulations thereunder subject to the following conditions: -
 - i. It is further informed that 15% of undergraduate seats of the permitted intake capacity of **100 seats** shall be treated as all India quota. The counseling for seats under all India quota shall be conducted by respective counseling authority as designated by Central Government for academic year 2022-23. **The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government/NCISM for all India quota or the students admitted thereunder.**
6. Admissions made in violation of the above conditions will be treated as invalid and action will be initiated under NCISM Act & Regulations thereunder.
7. Discrepancies, if any, may be immediately brought to the notice of Medical Assessment and Rating Board for Indian System of Medicine, NCISM.
8. **The following requirements should be fulfilled by the college by 31st December, 2022 to get permission for the session 2023-24:**
 - (i) all the requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016;
 - (ii) all the requirements of the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) Amendment Regulations, 2016 (for Ayurveda);
 - (iii) all the requirements, under the provisions of the NCISM Act-2020 and relevant Regulations, made thereunder should be fulfilled in toto;
9. The College administration will ensure that sufficient qualified teachers and non-teaching staff in the college and requisite staff in the hospital, as per the NCISM ACT and relevant regulation thereunder, are in position before the admission of the first batch of students in the 1st professional of BAMS is made, under intimation to the Medical Assessment and Rating Board, NCISM.
10. The college has to develop the requisite infrastructure for I, II and III professionals well in time as per the norms which will be verified by the medical assessment and rating board and accordingly the permission for taking admissions in subsequent academic session will be considered.
11. The college administration may take up the matter for recognition of the qualification under section 35 of the NCISM Act, 2020 at that time when the first batch of students admitted against this course appears for the first final professional examination of the said course.
12. The fulfillment of the condition given above may be made within the time period specified and compliance report should be submitted by the college to medical assessment and rating board for Indian system of medicine. The medical assessment and rating board for Indian system of medicine will verify that the conditions have been fulfilled for considering the permission matter from the academic session 2022-23.
